### **DWIGHT POST OFFICE**

The United States Postal Service held a meeting concerning the status of the Dwight Post Office on January 2nd. They reported that, of the 218 surveys that were sent out, 121 were returned. Based on the results, the Post Office hours will be reduced to 4 hours per day during the week. The new hours will be from 9 AM . 1 PM Monday through Friday and 11:30 AM to 12:30 PM on Saturday. Any mail put in the inside drop after the window has closed will not go out until the next business day. Mail in the outside drop box will be picked up a little earlier in the afternoon. The new hours will begin on Saturday, February 9<sup>th</sup>.

### **ELECTION**

The deadline for filing to run for City Office is Tuesday, January 22<sup>nd</sup> at noon. The positions that will be elected are Mayor and two Councilmembers which are the positions currently held by Galen Johnson, Eugene Anders, Sr. and Kenny Kaluhiokalani. At least one incumbent is not seeking re-election. The requirements to file for City office in Dwight are either \$5.00 or the signatures of five individuals who are registered to voter in Dwight. The paperwork must be turned into the County Clerk in Council Grove by noon on Tuesday, January 22<sup>nd</sup>. Remember that the Courthouse will be closed on Monday, January 21<sup>st</sup> due to the Martin Luther King, Jr. holiday. If needed, a Primary Election will be held on February 26<sup>th</sup>. The General Election will be held on April 2<sup>nd</sup>.

### **2013 CONSUMER CONFIDENCE REPORT**

The CCR is an annual report concerning the quality of water provided to you. A ruling has been passed down by the EPA that it is no longer necessary to mail the CCR to each resident as long as it is posted on the City website or provided by some other electronic means. Making this change will save water systems in Kansas more than \$900,000 annually in costs of postage, not to mention the cost of time in copying and assembly. If you do not have access to the internet, you may request a copy by contacting the City Office.
