

## Dwight City Council Minutes

August 19th, 2024

The Dwight City Council met for a regular meeting at the Library on August 19<sup>th</sup> 2024 at 7:00PM. Mayor Pam Goss opened the meeting with the Pledge of Allegiance. Other council members present were, Susan Mulryan, Ashley Gearhart, Brenda Anderson, and Chelsey Brosious.

Councilwoman Anderson made a motion to pay Advantage Computer (Jayhawk) \$3000.00 for new interface and mass meter conversion to be paid from the Water Fund. Councilwoman Brosious seconded. Motion carried 4-0
