The Dwight City Council met for a regular meeting at the Library on March 18th, 2024 at 7:00PM. Mayor Pam Goss opened the meeting with the Pledge of Allegiance. Other council members present were, Brenda Switzer, Peter Marquardt, Chelsey Brosious, and Ashley Gearhart.

Minutes: Councilwoman Switzer moved to accept the minutes of the February 19th, 2024 regular meeting with noted corrections. Councilman Marquardt seconded. Motion carried 4-0.

Maintenance Manager Report: Water Manager Ryan Taylor provided a written report.

Water Manager Report: Water Manager Ryan Taylor provided a written report. Ryan provided council with a copy of the "Lead Service Line Inventory Customer Survey" that is being used by Rural Water District 1.

City Clerk Report: Ken Bergeron provided written report and financials. Councilman Marquardt moved to go into Executive session at 9:37 not to exceed 10 minutes. Councilwoman Switzer seconded. Motion carried 4-0

Councilman Marquardt moved to go back into regular session at 9:47. Councilwoman Gearhart seconded. Motion carried 4-0.

Councilman Marquardt moved to increase Clerk pay by 25 cents per hour beginning with the next pay period. Councilwoman Switzer seconded. Motion carried 4-0.
